## CONDITIONS OF TRANSPORT, PACKING AND STORAGE OF FURNITURE

1. No articles must be packed in wardrobes/cupboards/trunks.
2. All water should be drained from washing machines and fridges.
3. Where motors of fridges need to be bolted down it must be done by owner or notify the contractor before the time.
4. All linen should be packed unless otherwise arranged with us.
5. Jewelry, ammunition, keys, medals and firearms must be transported by owner.
6. Any type of wine collections & beverages must be packed and sealed by owner and will be transported at your own risk.
7. It is the owner's duty to see that all items are loaded.
8. Delicate machines like open radios, record players, knitting machines, clocks etc. must be packed by owner unless otherwise arranged with us.
9. Sewing machines must be taken out of cabinets and packed separately.
10. Flowers and plants must not be watered before or during transportation.
11. Pot plants & garden furniture will be transported on your own risk.
12. Self-packed boxes and/or crates are transported on owners own risk. All goods packed in boxes and/or crates must be packed so that two men can handle it.
13. All electrical connections must be disconnected by owner himself.
14. No pigeon lofts, wire and poles, motor machines, cement blocks or trees will be transported unless previously arranged
15. All antique furniture, paintings etc. will be transported at owners' risk unless extra insurance has been arranged.
16. Please be aware that moving household items is risky. Our liability for loss or damages is limited. We are not responsible for all damages or loss you might suffer. Albertinia Meubelvervoer has a limited Goods in Transit insurance policy in case of fire, collision, overturning or high jacking only. It is important to also arrange your own insurance against all other insurable risks or arrange additional in transit insurance where necessary with an insurance company of your choice. You may also choose to contact your own insurance broker.
17. If owner allows vehicle onto the premises it is done at his own risk.
18. No furniture and or/goods will be carried if the distance is more than 50m between the truck and the point where the furniture and/or goods are collected/delivered. If the distance does exceed 50m then it is the responsibility of the owner to arrange a vehicle for transport of furniture and/or goods to the removal truck/residence. In case where the owner insists that the furniture and/or goods be carried further than the 50m, the owner will be held responsible for the risk of damage to the furniture and/or goods and the furniture removal company cannot be held responsible for any damage which may occur, within reason. A shuttle can be arranged by us if required.
19. Flammable fluids & paint will not be transported by the contractor. Only EMPTY 9kg gas bottles and less will be transported.
20. No claims can be made against the contractor if furniture is stored with another contractor and is not in order at time of re-delivery.
21. Any delay incurred by the customer in loading or off-loading of vehicle, will be charged out at R250.00 per hour.
22. A claim or dispute shall not be made the reason for deferring payment of any money payable to or liability incurred by the contractor. All payments need to be done prior to offloading.
23. Only items on inventory list will be loaded – make sure your inventory list is complete.
